Your Scores:

In this section are your highest scores on each component you have taken along with section averages and any associated feedback statements for portfolio components. Weighted scaled scores are your highest unweighted score (HUS) multiplied by its scaling weight (SW)* and rounded to 3 decimal places. (p. 15)

Total Weighted Scaled Score:

The total weighted scaled score is the sum of your weighted scaled scores from the four parts of Component 1 and the three from Components 2-4. The total weighted scaled score is rounded to the nearest integer. (p. 16)

* What is a scaling weight?

The scaling weight reflects a section's importance, or weight, within the total assessment. Each of the seven unweighted scores will be multiplied by a scaling weight to calculate a weighted scaled score. When added together, the seven weighted scaled scores make up your total weighted scaled score.
